
I am writing in follow-up to my letter of August 8. As the most recent rainfall continues to impact the amount of run-off affecting the Thistle property, I feel that finding a viable solution to resolve the issue needs to be a high priority. The persistent problem continues to cast Northern Ozaukee School District in a negative light, but, most importantly, primarily causes frustration for the Thistles and, secondarily, for other parties associated with the issue, as well.

I feel it is important that the school district, Village of Fredonia, and Regency Hills Development work together to effectively resolve the issue for the Thistles. It has been proposed that a committee be established with a school district board representative; Roger Sinnen, Buildings & Grounds Director; and village board representative for the purpose of finding a cost-effective solution. I would further recommend that Kendall Thistle be included in the discussions and formation of the solution.

It is my desire that you give serious consideration to the committee proposal. It is my expectation that I will hear from you in the near future. I look forward to our conversation.
